# Without Human Rights, Nothing Else Matters

- Human Rights are the basic foundation of all aspects of our daily lives
- Economic rights, civil rights & constitutional rights are all protected as Human Rights
- Education, practicing a profession, making a living & owning property are basic Human Rights
- Privacy and freedom from arbitrary interference and oppression by authorities are Human Rights
- All charitable and humanitarian causes are ultimately symptoms created by Human Rights violations
- All charitable work is only possible under the protection of Human Rights
- Human Rights are the ultimate cause underlying all other charitable causes
- Rights are not “rights” if the government can arbitrarily take them away



# Historic Movement of Global Impact

- **Human Rights solutions are already codified in 70 years of International Law**
- **UN Human Rights Laws are already fully binding upon all countries worldwide**
- **The most important Human Rights Laws have never been enforced – until now**
- **Only International Courts can enforce International Law, because sovereignty prohibits countries from asserting jurisdiction over any other countries**
- **The “treaty based” system is inherently limited by voluntary consent of sponsoring countries, who can “opt out” of jurisdiction and enforcement**
- **SCIJ is based on “Statutory Authority” of pre-existing UN International Laws**
- **No country can escape Universal Jurisdiction of SCIJ under binding UN Laws**
- **SCIJ is a historic accomplishment as a “next generation” Human Rights Court**



# Major Global Impact for Real Social Justice

- **First International Court established as Free from “treaty-based” restrictions**
- **First Court Licensed with Statutory Authority for binding Universal Jurisdiction**
- **Licenses permanent & irrevocable to guarantee full Judiciary independence**
- **First Court Free from UN or any country influence, as the real “People’s Court”**
- **First International Court to allow Individual Claims from or against all countries**
- **First “Court of First Instance” for International Law, bypassing country Courts**
- **First International Court with “in-house” institutional Enforcement Operations**
- **First Court dedicated exclusively to Black-Letter Rule of Law for the People**
- **Leadership example raises standards for Rights, Law & Justice worldwide**



# You Have the Power to Take Back Your Rights

- A trend of systemic dismantling of civil rights & human rights threatens “our way of life”
- Soldiers traditionally go to war to defend “our way of life”, meaning rights & freedoms
- While soldiers are given guns to fight for “rights”, “We the People” barely have enough rights left to merely protest to our own governments
- “Legal Warfare” by and for the People is needed to reclaim & restore Human Rights under International Law
- The “weapon” in this fight is SCIJ as an independent Court of Justice
- The “ammunition” is your Tax-Deductible Non-Profit Grants & Donations
- If we do not take up this fight, nothing else will be left that is worth fighting for

# Funding Strategy & Impact of Donations

- “1<sup>st</sup> Round” funding of \$3.0 Million USD was donated by Law Firms and non-profit organizations
- Effective use of grant funds over 5 years successfully established the SCIJ Court
- “2<sup>nd</sup> Round” funding now needed, from grass-roots & institutional sources, for launch of active Judiciary operations
- Every \$27,660 funds the full-time processing of 1 judicial case by the Court
- Every \$276,000 funds 1 year of a full-staff operation under 1 Judge for 10 cases
- A grass-roots audience of 1,000 donating \$276 each funds 10 cases
- Every \$2.7 M funds a 1 year operation of 10 Judges processing 100 cases
- A grass-roots audience of 3,000 donating \$900 each funds 100 cases
- Every \$2.9 M of Endowments fund 1 Judge for 10 cases every year forever



# Global Audience for Impact of Social Justice

- **The host IGO university is well positioned to raise public awareness and promote social justice, with impact on the legal and judiciary professions, on a global scale**
- **Social media targeted interest groups give an audience of 237,000+ professionals**
- **Four international Bar Associations give SCIJ access to 112,000+ Lawyers**
- **Networks of targeted social media groups and Bar Associations give SCIJ access to 21,000+ Judges**
- **An international Judges' Association of Non-Aligned Movement (NAM) countries gives SCIJ access to 6,600+ English-speaking accredited International Judges**
- **These networks cover all 193 countries of the United Nations member states**
- **Networks are both an audience for SCIJ to teach and promote Human Rights, and also a source of non-profit volunteers and expert talents to recruit from**



# Capabilities of the SCIJ Court of Justice

- **International Criminal Court (ICC) can process 1 case at a time, averaging 0.66 cases / year**
- **International Court of Justice (ICJ) can process 3 cases at a time, averaging 2.3 cases / year**
- **European Court of Human Rights (ECHR) can process 10 cases at a time, handling 1,100 cases / year at only 3 days each**
- **SCIJ is designed to process 10 cases at a time for 100 cases / year, giving proper full-time Judiciary attention to each and every case for at least 30 days**
- **UN & EU “treaty” Courts refuse 98% of all cases with prejudice, accept only 2%, of which 60% are dismissed with no remedy. Lawyers & Judges say: “where human rights cases go to die”**
- **SCIJ is designed to be expandable without limit, by endowment funding. Total global demand of approximately 100,000 cases / year could be handled by 10,000 full-time Judges, only 36% of Judges which SCIJ already has access to**





# Priority Need for Enforcement Mechanisms

- **“Justice should not only be done, but should be seen to be done.”  
- Lord Chief Justice Viscount Gordon Hewart (1923)**
- **International Law imposes a binding obligation on all countries to enforce International Court judgments**
- **UN & EU “treaty” Courts have no enforcement functions, officially consider judgments mere “tools for advocacy”**
- **Average enforcement of UN & EU Human Rights Court judgments is only the 21% rate of “voluntary compliance”**
- **All real enforcement requires Court Orders with strong penalties against governments which fail to enforce**
- **“Treaty” Courts can never do real enforcement, because penalty Orders would cause member countries to “opt out” and withdraw funding**
- **SCIJ as an independent non-treaty Court is Free to fully exercise universal jurisdiction with aggressive enforcement, by grass-roots and private funding**
- **SCIJ is the 1<sup>st</sup> International Court with statutory authority to use the full range of mechanisms for meaningful enforcement**



# Real-World Enforcement Power “With Teeth”

- Chamber of Compliance Judges – SCIJ division to oversee enforcement of judgments, register domestic liens & filings, issue punitive Orders
- Punitive Orders for Non-Compliance – Civil “contempt” & Criminal “obstruction of justice” Orders with severe penalties for each instance
- Critical Mass of Liabilities – Every adverse act is a new violation, “snowball effect” as liabilities of agencies & officials reaches “critical mass”
- International Alliances – NAM + BRICS 80% of all countries demand to restore International Law. Only ONE country needs to seize bank account funds of violating state’s Embassy in host country
- Economic Sanctions – Liens & Credit Report filings against agencies & officials
- Fast-Track Enforcement – 2 UN laws for automatic adoption of Foreign Awards
- UN IGO Advocacy – As IGO has diplomatic delegates to lobby UN sessions
